4,000 at **UI may** suffer from cuts

Still a dime

Approximately 4,000 UI students who had a 1980-81 Guaranteed Student Loan would no longer be eligible for the loan under the GSL cuts proposed by congressional committees July 21. John Moore, UI director of Student Financial Aid, said Sunday,

Moore said approximately 25 percent to 30 percent of the 12,000 UI students who received a GSL during the 1980-81 school year will be ineligible for the loan if the committees' recommendations pass Congress.

Students who have applied for 1981-82 financial aid will not see their aid reduced because the proposed budget cuts would not come into effect until Oct. 1. the first day of the federal government's new fiscal year. Moore

The House Education and Labor Committee and the Senate Committee on Labor and Human Resources voted to restrict the distribution of GSLs to only students from families whose annual income is less than \$30,000.

CURRENTLY students from all family income levels are eligible for a GSL and can borrow up to \$2,500 a

However, a student from a family earning more than \$30,000 can receive a GSL if the family can demonstrate a financial hardship that makes the federally insured loan necessary to pay for the student's education. "It's better than cutting students off

entirely." Moore said. The committees also voted to impose a 5 percent origination fee for obtaining such loans.

City to assess **Sheller-Globe** for damages

Iowa City will assess the Sheller-Globe Corp., at least several thousand dollars because of an early June mineral oil spill that has shut down normal operation at the city's sewage treatment plant.

City documents state: sewage digestors at the plant deteriorated until the plant was forced to stop pumping sludge to the digestors June 19. Steps that the city has taken to temporary compensate for the loss of the digestors are currently costing the city about \$500 each day.

A city notice and order has informed Sheller-Globe it will be liable for all city expenses resulting from the spill. The Iowa City Council will consider a Sheller-Globe request for a hearing during its Tuesday night meeting. The corporation requested a hearing and filed documents July 10 notifying the city of its intention to appeal the order.

"WE'LL PROBABLY ask for a hearing far enough into the future to allow both parties ample time to check things out," City Manager Neal Berlin

Sheller-Globe is very concerned," he said, noting the company shut down the heat exchanger that had been leaking the mineral oil shortly after company officals notified of the spill.

"They had to request a hearing within ten days to protect their

rights," Berlin said. The city code states failure to request a hearing within ten days after a notice is served constitutes a waiver of the right to a hearing and makes the city order final. The Sheller-Globe response states that it "denies all allegations and contests all of the claims and orders" because the ten-day petition period has not given the company time to determine the accuracy of the city's allegations or the reasonability of the city claims.

THE CITY ALLEGES mineral oil from an early June spill at the Sheller-Globe plant on Highway 6 is responsible for rendering digestors at the sewage plant inoperative.

The city notified Sheller-Globe in a June 30 letter that it was liable for all city expenses resulting from the spill, and ordered Sheller-Globe to construct interceptor devices to prevent future spillage from entering city sewers.

Iowa City Pollution Control Superintendent Harry Boren noticed a large volume of an oily substance entering the sewage plant June 9, the city letter states.

Boren called the Sheller-Globe plant engineer, who stated the plant had a heat exchanger that had been leaking mineral oil for some time. The engineer informed Boren the next day that the faulty heat exchanger had been shut down, the letter stated. See Sewer, page 7

The decision by the committees was a compromise between the House, which had proposed that students from families whose annual incomes exeeds \$25,000 a year no longer receive a GSL, and the Senate, which had proposed that GSLs be given to students from families with an annual income of more than \$25,000 if the students can demonstrate actual need.

THE \$30,000 adjusted income cap is "a decided relief rather than a lower cap." Moore said.

Willis A. Wolff, executive director of the Iowa College Aid Commission, said Friday, the committees' agreement is 'a great deal less restrictive'' than the past proposals.

"It will cut our (students in Iowa's post-secondary schools) loan volume some," she said. Wolff said she could not estimate the

number of students that would be affected by the loan proposal because last year students did not have to list family income on the loan application. Wolff said she has been pushing for an income ceiling so all students do not have to send in a need analysis with

their application.

"IT WILL CUT down the work for schools, banks and the expense of students," she said. "I'm very pleased." The compromise by the House and Senate committees was a surprise, Wolff said. "It was a major concession. It's very favorable. Congress should be congratulated."

Both the Senate and House committees proposed cutting the number of students eligible for GSLs in order to save the money required by President Reagan's budget cuts.

Moore said it is too early to know how many federal financial aid dollars would be lost by UI students because of he new proposal.

Democrats wooed

WASHINGTON (UPI) - President Reagan invited 15 House Democrats to Camp David Sunday for a free lunch and some low key politicking on his tax cut legislation nearing a crucial vote in Congress.

According to several of the participants, the president, relaxing as his guests downed hot dogs and hamburgers, underlined the differences between his tax cut bill and the alternative offered by the Democratic House leadership.

For most of the Democrats, it was their first visit to the presidential mountaintop retreat in northwest Maryland. Many were clearly thrilled by what they considered to be preferential treatment.

The group included Eugene Atkinson of Pennsylvania, Charles Bennett of Florida, Beverly Byron of Maryland, Glenn English and David McCurdy of

Oklahoma, Billy Lee Evans and Charles Hatcher of Georgia, Ralph Hall and Kent Hance of Texas, Bill Hefner of North Carolina, Jerry Huckaby of Louisiana, Romano Mazzoli of Kentucky, Ron Mottl of Ohio, Richard Shelby of Alabama and Ike Skelton of Missouri.






While critics point to shortcomings, defenders say the nonpartisan approach has encouraged public interest and has avoided creation of unfair districts. If the nonpartisan approach looks bad, they say, the fault should go to the late release of census figures or political machinations.

THE NONPARTISAN approach, adopted nearly unanimously by the legislature, called for the LSB to draw three plans. The General Assembly could vote only to accept or reject the first two. The third can be amended. Legislators convene Aug. 12 in the second special session of the year to work on reapportionment. They face a Sept. 1 deadline - set by the constitution - for adoption of a plan.

"I think it was a good idea and it was efficient," said Mary Grefe, who headed the Temporary Redistricting Advisory Commission, "but it just wasn't political."

The commission held public hearings on the first two plans. Republican and Democratic members disagreed so strongly over the second LSB plan that they adjourned without deciding whether to call hearings on the third plan - or even if they would meet again.

Space shuttle test delayed

CAPE CANAVERAL, Fla. (UPI) - NASA announced another postponement Sunday in the scheduled start of a test to determine if the Space Shuttle Columbia is ready for its second flight on Sept. 30.

Only hours before the test was to begin Friday, shorts were found in the wiring of the "bionic arm" of the ship. A short circuit would discard the arm in space if it malfunctioned while extended. The latest change moved the start of the test back to midnight Monday.

Report finds no conspiracy

WASHINGTON (UPI) - The FBI has turned up no evidence indicating that John Hinckley, the man accused of shooting President Reagan and three others last March, was involved in a conspiracy to kill the president, an agency spokesman said Sunday.

FBI spokesman Anthony Schiappa said, "The bottom line is the investigation did not turn up any evidence of a conspiracy."

Hot air ballooning canceled

INDIANOLA, Iowa (UPI) - Officials at the National Hot Air Balloon Championships said rain Sunday caused the cancellation of opening day ceremonies and a mass ascension of balloons at the event.

Pilots said they were not sure winds were slow enough for launchings.

Spokesman Bill Martin said the mass ascension will be scheduled for another time during the week-long event.

Belize to gain independence

LONDON (UPI) - Belize, the last British colony in Latin American, will become independent Sept. 21, the Foreign Office said Sunday.

The 23,000 square mile colony of 151,000 people, formerly known as British Honduras, has been the focus of a lengthy dispute with Guatamala, which laid claim to part of its territory under a 19th century treaty with Britain.

Nerve gas will be moved

DENVER (UPI) - The U.S. Army is making final plans for the largest transfer of toxic chemical munitions in more than a decade. A tiny drop of the nerve gas can cause almost immediate death.

About 150 tons of GB nerve gas will be moved by the end of the summer from the Rocky Mountain Arsenal near Denver to the remote Tooele Army Depot in the northwest corner of Utah.

A "middle" funeral cost would be \$2,100 to \$2,400 and would include casket, services, personnel costs and other expenses, Gay said.

Funeral costs are given over the telephone, he said, adding, "I don't know of any funeral director that doesn't" give prices over the telephone. Gay said parlors provide predisclosure statements of funerals "99 percent" of the time.

PHILADELPHIA (UPI) - Fibers ca found on the bodies of the two Atlanta blacks Wayne Williams is charged with killing, have been linked to fibers found on 12 other young victims in the twoyear string of slayings, a published report said Sunday.

In a copyright story, the Philadelphia Inquirer quoted an unnamed Atlanta investigator as saving authorities wanted to watch the progress of the first two murder prosecutions before taking action in the other cases.

In Atlanta, police had no comment on the report

Atlanta Mayor Mayard Jackson, speaking in Columbus, Ohio, also had no comment. Jackson said officials want to be super-careful to make sure we don't say anything that might preindice the investigation."

ACCORDING TO the Inquirer, investigative sources said fibers from Williams' bedroom rug, bedspread, and from the family car he used, matched those found on Jimmy Ray Payne, 21, and Nathaniel Cater, 27, whose bodies were pulled from the Chattahoochee River.

Williams, 23, a free-lance television cameraman, was indicted July 17 in those deaths.

The Inquirer quoted the sources as saying similar fibers were also found on the bodies of six victims discovered in Fulton County, five found in DeKalb County and one found in Rockdale County. .



Emmylou UI Opera performs rich 'Magic Flute'

The Magic Flute, performed by the **UI** Opera Theater and University Symphony Orchestra Thursday and Saturday at Hancher Auditorium, was a richly-mounted endeavor that showcased some amazing musical talents but missed out on serious theater. Mozart's opera is a long, involved fantasy about princes, princesses, supernatural forces and above all, the search for enlightenment and wisdom. It was the last opera Mozart composed, and many say, the best.

When one has seen Ingmar

Bergman's magical film version of the opera, it's hard to be satisfied with anything else, including live productions. Most of that movie was filmed on an actual proscenium stage, but the advantage of close-ups, animated actors and complete subtitles made it a truly exceptional experience. With the UI production, one got the musical satisfaction but lost out on the glittering potential of the characters and the action

problems, the singing by the prin-cipals, especially. Michael Ketcherside's Prince Tamino, Sharon Bennett's soaring Queen of the Night and Albert Gammon's solemn Sarastro, was beautifully phrased, with only minute traces of off-key notes.

While Robert B. Dundas as the bluecolored Moor, Monostatos, lacked a commanding operatic voice, his exaggerated movements gave the production a much-needed element of levity, a chore that traditionally falls to Papageno, the Bird Man. As played by David Reinhardt, Papageno started

his grimacing faces and childish line readings. It wasn't until Papageno had his Papagena (Sara Jones) to play off in the whimsical "bird" duet that Reinhardt finally achieved a state of comic naturalness.

WHAT THE production lacked in theatrics and acting prowess (the age when opera singers merely stood around belting out arias is long over). it made up for in the visual pleasure afforded by the gorgeous costumes and simple, but grand scene design by John Conklin, who did them originally for

EXCEPT FOR some diction off trying too hard to get laughs with the Opera Theater of St. Louis. During the overture, the lights slowly came up on a starry set that eventually highlighted an enormous golden sun. David Thayer's lighting design was a

triumph of moods and atmosphere. About the only technical flaw came in Thursday's performance, when Pamina's beautifully emotional lament over Pamino, sung by Kathryn Focht, was marred by ugly microphone static.

Empty ruins from modern stone age

High up on a hill, overlooking the town, the ruins of this stone mansion reflect the rise and fall of Stone City, Iowa, once a flourishing community of stone quarries in the mid-1800s. J.A. Green, an Irish immigrant, established Champion Quarry there

In 1873, Green named the community Stone City. The quarry business flourished with the arrival of the railroad in 1859 and the community's stone made its way throughout the Midwest. Green was a conspicuous consumer of his own product and built several stone buildings on his 1,000-acre estate, including a large water tower, an ice house, a carriage house, a three story stone barn and Columbia Hall, a massive stone structure containing an opera house and 56 guest

Unfortunately for Green, the turn of the century brought with it the introduction of cement to the construction world. As a result, the quarry industry dwindled and Stone City was reduced to a near ghost town. Green moved his family to Cedar Rapids in 1919, where he died in 1920.

HARRIS AND her Hot Band performed two shows, one at 6:30 p.m., the other at 8:30 p.m. The first show lasted just under an hour (there was no opening act) before a considerably-less-thancapacity crowd. The second show reportedly lasted over an hourand-a-half for a full house and had the benefit of stage lighting (after dark). "C'est la vie," say Chuck Berry and Harris, "it goes to show you never can tell."

The "Hot" Band is a bit of a misnomer, particularly in the absence of guitar-whiz Albert Lee. "The Room-Temperature Band" might be more appropriate, as Harris' backing group lends comfortable, if generally unspec-tacular, support to the selected

songs. The band's strength lies in its versatility, as evidenced by Wayne Goodwin (fiddle, tenor sax and mandolin), Steve Fishell (pedal steel and dobro guitars), Frank Rekard (mandolin, backing vocals and electric and acoustic guitars) and Barry Tashian (banjo, vocals and guitars). The other band members are pianist Don Johnson, bassist Michael Bowden and drummer John Ware.

ALL OF THE SONGS performed were tight and professional, marred by a few occasions when the Hot Band (or their sound engineer) would lose control and run over Harris' vocal.

Highlights were a superb rendition of Paul Simon's "The Boxer," a duet with Tashian on the Louvin Brothers' "If I Could Only Win Your Love," a beautiful ballad entitled "Miss the Mississippi," and the foot-stomping "Leaving Louisiana in the Broad Daylight." The singer dedicated "One of These Days" to her mother in Maryland who she said had fattened her up so much during a recent visit that she had to wear a skirt because she couldn't fit into her jeans anymore. Moms are like that.

The "10 percent uptown" was taken care of by a shimmering version of Harris' current hit "Mister Sandman" and a surprisingly credible "How High the Moon" (which Ella Fitzgerald has owned since she first laid voice on it).

The band's arrangement on "How High" was impeccable, recalling the work of Stephane Grappelli and Django Reinhardt's Quintet of the Hot Club of France in the 1930s and making for a nice break in the country-rock show in the process.

All in all, a solid, professional show from a group of solid professionals.

The question is not whether Bo Derek can act, it's rather should she be allowed to continue? In remaking Tarzan, the Ape Man, Derek, as star and producer, and her husband John, as director and photographer (he insists he's the only one who knows how to properly view Derek through a lens darkly), the perfect 10 has ventured into the steamy jungles of Africa and come forth with a white elephant.

There's something perverse about a husband who's so anxious to show off his wife's breasts to the world. As Jane Parker, the heiress who trots out to Africa to see her explorer father James, Derek always sports lacy dresses which she invariably wears into rivers, lakes and streams so as to better show off her wet nipples.

DEREK'S SEX APPEAL is kittenish and low-key; completely opposite the aggressive sexuality of, say,

Javne Mansfield. Derek isn't threatening in the least. Her little girl voice and cloying habit of putting her finger to her lips are no more of a turn-on than an old Farrah Fawcett poster.

When Jane talks of personal libera-tion — she wants to be free like the guys - she squares her shoulders and narrows her Orphan Annie eyes. But Derek can't carry a scene for more than a few seconds when there's dialogue. Derek is a model who can fill a screen while frolicking naked in an inland sea, but when she makes verbal love to Tarzan ("I'm a virgin. Are you a virgin? Or course, you are. Who else is there out here?"), she's flat and uninteresting - a child reciting childish fantasies, as totally devoid of eroticism as a textbook on grammar.

THE MOVIE is actually misnamed. Tarzan, who wears a loincloth that barely covers his assets, is played by a former Tennessee football player named Miles O'Keeffe. He lets go with his famous yell about half a dozen times, but beyond that, he's forced to fit into the mold of the strong, silent type who fills in time between Derek's playful exercises. In a scene meant to be the height of sensuality. Tarzan discovers Jane's breasts (they're already old hat to us) and looks blank while Jane widens her eyes and utters "Oh, God" over and over.

After this, all Tarzan gets to do is save Jane from imminent disaster time and again. Unfortunately, John Derek has not the faintest idea of how to build and exploit suspense.

WHEN THE James Parker safari is captured by brightly-painted natives, Tarzan doesn't stealthily check out the camp to consider the odds, nor does he take advantage of the herd of elephants that backs him up. All you see is Tar-

zan suddenly jumping on the head dity with his own. savage (who inexplicably wears a Tom Rowe and Gary Goddard's Mohawk haircut) and engage in a screenplay is a mixture of inadvertent prolonged, slow-motion battle that camp and teen-age Freud. Derek talks looks like an outtake from a homosexual stag movie.

As evidenced by some gorgeous photography, John Derek does have an eye for beauty. Unfortunately, he also thinks he has a handle on bringing art into trash. He slows the film down repeatedly. The time Derek gets a boa around her neck starts out as an essay in surrealistic agony but goes on so long the agony of boredom is transferred to the viewer.

POSSIBLY the only ones who come out of this mess without embarrassment are Tarzan's orangutan and monkey friends. Richard Harris plays Jane's father in so broad a way that at first you think the jungle heat has got to him. You eventually realize the crafty Harris was the only one who knew what a turkey he was working on and so transcends the cinematic absur- Campus 2.



CIA head Casey to see committee

WASHINGTON (UPI) - Embattled CIA Director William J. Casey delivered documentary evidence to the Senate Intelligence Committee Sunday, hoping to resolve the controversy over whether he should resign his job.

The documents were accompanied by a letter from the CIA which said Casey was 'respectfully requesting a committee hearing as soon as possible.

Casey beat his schedule by a day. The committee expected him to respond Monday with "all materials requested." It also expects to receive its own staff report Tuesday on the director, who is under fire for his choice of Max Hugel as CIA spymaster and questions about his own past business deals.

A CIA statement accompanying the material said, "Mr. Casey said he believed it is in the best interests of the country that this matter be handled expeditiously and to facilitate that he would be pleased to appear personally before the committee and extend his full cooperation on any matters into which committee members may wish



to inquire."

CHAIRMAN Barry Goldwater, R-Ariz., and ranking Democratic member Daniel P. Movnihan, D-N.Y., were to meet with the staff to examine it.

Goldwater has said he thinks Casey should step down because the choice of Hugel - who resigned this month because of allegations about past business deals - and questions about Casey himself have damaged morale at the agency. Several other key GOP lawmakers have

joined Goldwater, but others this weekend said they wanted to wait until the hearings to give Casey a chance to tell his side.

Sen. Henry "Scoop" Jackson, D-Wash., on NBC's "Meet the Press" Sunday, likened the public condemnation of Casey by some senators to "McCarthyism," a reference to the communist-hunting era of Sen. Joe McCarthy, R-Wis.

BUT JACKSON denied that he was criticizing Goldwater, saying "a number of senators" have called for Casey's resignation without committee hearings.

He said Casev made "a tragic mistake" in appointing Hugel "to a very, very sensitive post," but said the appropriate place to discuss the matter first is in a closed

A royal wedding is full of pomp and pageantry

LONDON (UPI) - At heart it is a simple thing. A lovely girl just turned 20 and a slim, athletic man of 32 vowing before a clergyman to "love, comfort, honor and keep" so long as they both shall live.

But the slim young man is His Royal **Highness Prince Charles Philip Arthur** George, Prince of Wales and a halfdozen titles besides. In time he will be "by the Grace of God, of the United Kingdom of Great Britain and Northern Ireland and of His other Realms and Territories King, Head of the Commonwealth, Defender of the Faith.'

The girl is Lady Diana Frances Spencer, five times descendant of King Charles II, born into England's true aristocracy of landed wealth, a blonde beauty who instantly enthralled the people over whom she will reign.

WITH SUCH a groom, let alone such a bride, the July 29 wedding of Prince Charles and Lady Diana cannot be merely a simple thing.

"A princely marriage," wrote political commentator Walter Bagehot a century ago, "is the brilliant edition of a universal fact, and as such it rivets mankind.

Much of mankind - by latest estimate, 1 billion people - will watch or listen riveted to the pomp and pageantry and majesty which sets this simple wedding-service jewel into a magnificent mounting.

The processions, the flags and bunting and celebrations will be essentially the same as those for the weddings of Charles's sister Anne or his aunt Margaret, for his mother's 1977 Silver Jubilee or his grandmother's 80th birthday.

Dollar pleases tourists

PARIS (UPI) - The dollar's new strength against European currencies has brought smiles to the faces of Americans vacationing in Europe.

'Now you don't have to worry about getting hit over the head when you buy something," said Tom Ward, a Kansas State University graduate traveling in France

But if many Americans are being cheered by current European prices, U.S. embassies in Paris and London also report no slackening in visa requests for Europeans to vacation in the United States. Rome even says the number is up by 12 to 15 percent from 1980.

Tourist officials explain that many people on both sides of the Atlantic had made vacation plans before the dollar soared. Even British hotel and tourist officials, anticipating a bonanza because of Prince Charles' wedding, are griping at the absence of Americans in the final run-up to Wednesday's ceremony.

FRED PEARSON, director of the London Tourist Board, said last week that neither the cheap pound - \$1.86 compared to last November's high of \$2.45 - nor the attraction of the royal wedding had provided the expected boom.

"The change in the dollar has come too fast and not at the right time at all," he said. "There may be some last-minute decisions to come, but a lot of the expectations over the wedding were just wishful thinking.

Jill Evans, public relations officer at London's medium-range Royal Garden Hotel, which charges as much as \$132 a night, agrees.

There are quite a few coming, but not as many as we thought. I think the lead-in time was too short - people were booking their holidays before the wedding was announced."

Artificial heart keeps man alive for 2 days

HOUSTON (UPI) - Doctors put a human heart Sunday in a Dutch tour bus driver who had lived 54 hours with a plastic pump in his chest. Hours later, he squeezed a doctor's hand, but his condition was "touch and go."

A team of 25 doctors at the Texas Heart Institute in St. Luke's Episcopal Hospital worked feverishly to save Willibrods A. Meuffels, 36, whose condition deteriorated to critical and unstable following the three-hour tranplant operation.

"It's touch and go," was the last report hospital spokesman Pat Kiley gave at press time Sunday.

Doctors replaced the mechanical pump that had kept Meuffels alive for more than two days with the heart of a Tennessee man declared neurologically dead after an automobile accident.

HOSPITAL SPOKESWOMAN Hazel Haby said after the transplant, "There was a big cheer when people watching it on closed-circuit television around the hospital saw it start to beat right off the bat.'

The chief concern then became whether Meuffel's blood would clot adequately.

"The heart is beating strongly," Haby said. "He responded to verbal commands. One doctor said, 'Can you squeeze my hand?' He did. 'Can you move your arm?' He did. He can't talk

because of a tube in his throat." But Kiley said Meuffels' bloodclotting problem worried physicians. although "in the first 24 to 48 hours. there's typically some swings - it's up and down.

"The difficulty is the matter of blood coagulation - he was not clotting enough. It's not an uncommon problem in transplantation but until that's under control, we won't consider him to be as stable as we'd like him.


THE CARDIOVASCULAR surgical team that performed the surgery was headed by Dr. Denton Cooley, whose decision to implant the artificial heart raised questions whether he acted unethically or violated Food and Drug Administration rules regarding prior approval.

Cooley said he did not need FDA approval for emergency implantation of a non-marketed device made by his Texas Heart Institute. FDA spokesman Wayne Pines, reached by telephone in Washington, tentatively agreed. "In an emergency situation, as ex-

The donor's kidneys and the corneas of his eyes also were taken from his body for transplanting into other patients.

The Palestine Liberation Organization Sunday reprimanded one of its splinter factions for rocket attacks that disrupted a 3-day-old cease-fire along the Israel-Lebanon border but Prime Minister Menachem Begin said the PLO itself would be held responsible for violations by any guerrilla group.

"If the arrangement is broken, we don't care who breaks it," Begin's spokesman quoted the prime minister as telling Reps. Tom Lantos, D-Calif., and Milicent Fenwick, R-N.J., after a meeting in Jerusalem.

There were no fresh cease-fire violations Sunday and PLO chairman Yasser Arafat, interviewed on ABC's "Issues and Answers," said the durability of the accord "doesn't depend on us. It depends on the other side "



THE TAX CUT BILL, and a Democratic alternative are expected to be scheduled for votes on the House floor this week.

Reagan will focus exclusively on that tax fight during his Monday night address from the White House. He shelved the idea to divide his remarks between the tax bill and his planned changes in the Social Security system after Republicans in Congress told him the timing was wrong for a statement on Social Security.

Reagan carried two drafts of the speech for editing during his stay at Camp David.

The president believes "this is a critical week" and that there are signs the momentum is shifting to the administration tax package, Gergen told reporters over the weekend. Reagan, said Gergen, "feels a great deal is at stake: the success of his economic recovery program.

'The issue on taxes is still in doubt," said Gergen. It's still uphill. But we believe the president is beginning to close the gap and we're encouraged by that. We anticipate it will be a close vote.'

The administration is holding fast to the basic concepts of the president's tax cut bill. The duration -33 months — and the size of the reduction — 25 percent - remain unchanged. However, many so-called "sweeteners" have been added to lure support from representatives in oil and farm states.

Holes outlined in strangler case

LOS ANGELES (UPI) - Prosecutors considered heir case against accused Hillside Strangler Angelo Buono to be unwinnable even before they decided a ury would not believe their star witness, it was reported Sunday.

The Los Angeles Times said prosecutors Roger Kelly and James Heins wrote a lengthy memo to District Attorney John Van de Kamp, which outlined holes in all 10 murder cases against Buono.

The memo showed that problems of conflicting and inconsistent information existed with all 10 murder cases aside from the contradictory statements of key witness Kenneth Bianchi, the Times reported. In the private memo, written July 2, prosecutors said that Bianchi, Buono's cousin and co-defendant, 'would not be believable" before a jury and listed problems with corroborating witnesses. prints.

PROSECUTORS asked Superior Court Judge Ronald George to dismiss charges against Buono July 13 on grounds that Bianchi's flip-flopping testimony had made him ineffective as a key witness

George denied the motion and ruled there was enough evidence to proceed with Buono's scheduled Sept. 15 trial.

The memo also said the coroner's findings did not support the prosecution's conclusions in certain theories involved in the slayings investigations.

Among the holes in the case, reportedly outlined in the prosecutors' memo, was a palm print found on the car of the 10th strangler victim, Cindy Hudspeth, 20, which did not match either Buono's or Bianchi's







Sports Players to discuss strike position today NEW YORK (UPI) - Represen-

tatives of striking major league players will meet today in Chicago to review their position in the snarled negotiations with club owners. Marvin Miller, executive director of the Players Association, will brief the

player representatives from the 26 clubs on the status of the protracted talks. He is believed to have two proposals regarding free agent compensation - which he considers unacceptable but might be accepted by the executive board.

With the strike in its 45th day and more than 25 percent of the schedule already canceled, a threat has arisen that the major league parks will remain closed for the duration of the season. The strike began June 12 and even if a settlement is reached next week, it is doubtful if play could esume until about Aug. 6.

THE PLAYERS ASSOCIATION also is planning a series of regional meetings to provide an update on the negotiations.



Sheller-Globe Corporation has agreed to pay a \$200 fine in response to an investigation into alleged dumping of toxic waste into the city's landfill last year, a corporation spokesman said Monday.

The state Department of Environmental Quality filed a petition Monday in Johnson County District Court against Sheller-Globe, accusing the company of disposing methylene chloride, a toxic waste also known as dichloromethene, from its Iowa City plant into the landfill on Sept. 2, 1980.

The petition asks that the corporation "be penalized \$500 and that it be taxed with the costs of this action." In addition, it asks for a permanent injunction to bar future illegal disposal of any toxic or hazardous wastes.




team Both players feel that minor league baseball has a lot to offer. Each player professed chances may be slim to make the major leagues, but hard work and the right break are all that is needed

IN COURT DOCUMENTS filed Monday, the company denied dumping a drum of the waste.

Bob Snell, director of public relations for the company in Ohio, said an investigation by the Department of Environmental Quality after the waste was discovered was "inconclusive."

Sheller-Globe agreed to pay a nominal fine of \$200 "to make the whole thing a matter of public record," he said. The company has also instituted a series of modifications for dealing with hazardous materials, and has agreed to allow the department to continue monitoring its waste disposal, Snell said. A judge has not made a final ruling on the case, he said.

The department was asking for \$500 and an admission of guilt, Snell said, but "we made no admission of guilt." He said the investigation resulted in no conclusive evidence.

METHYLENE CHLORIDE is a "skin irritant," said Eliza Ovrom, assistant attorney general who filed the petition for the department. "Because it is a toxic waste, we thought we should file (a petition)," she said

After "lengthly negotiations" with attorneys of Sheller-Globe, an agreement was reached for the "lesser amount," Ovrom said.

"We have been assured by Sheller-Globe that it (illegal waste dumping) won't happen again," she said. The Iowa City plant produces "pad-ded products for the automotive industry" such as arm rests and dashboards, Snell said. Methylene chloride is "an industrial solvent" used at the plant, he said.
